Lower your energy costs in 3 easy steps

1. Schedule an assessment

Start with a Home Energy Assessment for only \$100[†] (a **\$400 value**). A Participating Contractor will evaluate your home's systems and check for moisture, drafts, and mold. They'll also install energy-saving products like LED bulbs and advanced power strips at no cost.

2. Ask about rebates and financing

You'll get a report that details your home's energy use, with recommendations for money-saving improvements. You may earn rebates **up to \$7,500** and even qualify for low-interest loans (starting at 0% for 12 months).[‡]

3. Complete energy-saving improvements

Once the improvements are completed, a final test is done to ensure there are no air quality or safety issues. Your contractor will submit a signed job completion form **within 30 days** to ensure that your rebate check will arrive within six to eight weeks.[§]
