Eligibility

- County, municipal, city, or town government agency
- Public school district or publicly funded college or university
- Nonprofit organization, religious institution, or community service organization or facility
- Delmarva Power Maryland customer with a commercial electric account

Delmarva Power Account Executives make sure you meet the eligibility requirements, complete applications, and find Service Providers. They also provide advice and guide you through the program requirements.

Program Participation

- Identify an Energy Champion—the facility's point of contact—who meets with the designated Account Executive, takes trainings, and assists with program applications
- Develop an implementation plan to identify goals, facilities, measures, and a timeline
- Meet with Delmarva Power quarterly to review program details and goals
- Receive pre-approval of every project
- Send one member of the operation to complete an Operations and Maintenance Training course during the 2024–2026 program cycle
- Complete all project work by Nov. 19, 2027



Incentives

Customers in the Energy Efficient Communities program can receive any incentives offered through Delmarva Power's Energy Savings for Business program. Account Executives work with each establishment every step of the way to identify projects that best meet its needs.

Engineering Services

Our team will review the planned projects to determine the appropriate application type. Applications can be in one of two categories: prescriptive or custom/new construction projects.

Prescriptive Projects

- Review specifications to make sure equipment qualifies and assist with workbooks and completion of online applications
- Provide program criteria and incentive guidance if equipment does not qualify
- Identify potential energy savings to help with project design

Custom/New Construction Projects

- Determine comparison baseline, program-acceptable calculations and preliminary cost effectiveness; review required documentation
- Offer Custom Applications Workshops, held throughout the year
