Eligibility

- Offer open to all Delmarva Power Maryland residential customers. Limit one rebate per qualified clothes washer, per Delmarva Power residential account on rebates submitted beginning January 1, 2018 or while funds are available.
- Rebate application must be accompanied by proof of purchase including a copy of the dated sales receipt with model number.
- Certified clothes washer must be a new appliance and it must be purchased in Maryland, or the buyer must demonstrate having paid the applicable Maryland sales and use tax.
- Rebate application must be postmarked no later than 60 days from purchase date.
- \$75 rebate is for select ENERGY STAR certified clothes washers; \$100 rebate is for super-efficient ENERGY STAR certified clothes washers.
- Details such as rebate amounts and eligible appliances are subject to change at any time.
- The rebate paid will not exceed the purchase price of the appliance.
